 - Photocopy of PAN Card in the name of firm.
 - Bid security declaration is to be submitted by the bidder (as per annexure B) on legal stamp paper.
 - Tender fee and Security deposit are not required for those bidder who are registered under MSME and associated in make in India.
 - Photocopy of GSTIN Registration certificate along with SAC Code.
