- (b) Affidavit for proprietary/partnership deed/Article of Association including change in constitution of firm during last three years.
- (c) Character Certificate from District Magistrate, (for outside parties bidding first time), same is not needed for contractor working in ITI Mankapur, Gonda.
- (d) Photocopy of PAN Card in the name of firm.
- (e) EMD of Rs.3900/- ( Rupees three thousand nine hundred only).in shape of demand Draft in favour of ITI Ltd., Mankapur ).Same is exempted for MSME registered agencies.
- (f) Tender cost of Rs 500.00 in shape of IPO/DD in the the name of ITI Limited ,Mankapur.)
- (g) GST in Registration in favour of Tenderer if annual turnover is more than 20.00 lacs. All above documents should be signed and submitted along with technical bid in envelop no (1) as token of acceptance.
