General Specifications for both types of Panels -

- i) The Distribution Panels shall be Indoor Type, Base Mounted with ground clearance of approx. 300 mm along with angle frame (40 x 5 mm) and provision of grouting.
- ii) Panel shall be duly powder coated in Siemens gray colour.
- iii) Panel shall be compartmentalize and made of 2 mm CRCA sheet steel of load bearing and 1.6 mm of non load bearing. Every compartment shall be equipped with lock and key arrangement.
- iv) All the interconnections inside the panel for different switchgears shall be with suitable sizes of bus bars only. Minimum size of the bus bars shall be calculated as 1 Amp = 1 Sqmm. All the bus bars shall be with colour coding bus bar sleeves and shall be supported with Bakelite.
- v) All bus bar nut-bolts shall be cadmium coated and minimum M12 of 5.6 grades or better.
- vi) Bus Bar chamber shall be properly covered with Bakelite to prevent contact accident.
- vii) All the control MCBs shall be wired with suitable sizes of flexible wire.
- viii) All insulators used in the panel shall be non hygroscopic.
- ix) All the ACB / MCCBs shall be mounted in suitable size of panel.
- x) Gland plate required at top and bottom.
- xi) Suitable arrangement shall be provided in the Cable Alley Chamber for support of cables.
