iii. That the item(s) should not be diverted, sold or transferred to any Third Party whatsoever except as indicated in EUC.

iv. If required, verification/certification that possession of the item(s) has occurred would be provided.

v. The item (s) should not be used for any purpose that relates to development of weapons of mass destruction and their delivery systems.

3. This Authorisation is further subject to compliance of Export and Import Policy of the Government of India, as amended from time to time.

4. This Authorisation is valid for a maximum period of **2 Years 0 Month** or completion of the order, whichever is later.

5. The Firm is directed to submit a copy of the Authorisation duly endorsed (quantity of item exported) by concerned customs authority after export of each consignment.

6. This Authorisation is being issued for port of loading/port of shipment indicated in the application. If there is any change subsequently, endorsement from Department of Defence Production must be taken.
