	<b>b.</b>	The bidder should have Minimum Annual Turnover Rs.2 Cr. in Fy: 2019-20, 2020-21 & 2021-22. Proof is to be provided.
	<b>c.</b>	Net Worth should be positive in Fy: 2019-20, 2020-21 & 2021-22.
