- Dismantling shall include **removal and disposal of dismantled material** complete.
- PCC shall be of mix **1:4:8**.
- RCC shall be of **M-25 grade concrete Nominal Mix/ Design mix**.
- Reinforcement steel shall be of **Tata / Jindal / JSW Neosteel** make.
- Cement shall be of **ACC / Ambuja / UltraTech** make.


