#### 1) **ELIGIBILITY CRITERIA**:

The Bidders should quote only, if they satisfy the following eligibility criteria

- 1. The bidder should have **GST and PAN** registration and **License to trade** white bread. Self-attested copies of the document should be submitted.
- 2. Bidder should be an authorised/wholesale distributer of the brand quoted in Palakkad District, Kerala and **proof** is to be submitted along with bid.
- 3. Address / Contact details of the bidder including email ids, phone number etc, should be furnished with substantiating **documents** like electricity bill/telephone bill/water bill /lease agreement /Registration certificate etc.

The registered MSE bidders with valid certificates are exempted from submission of EMD.

- 9. EMD will be refunded to the unsuccessful bidders after finalization of tender process.
- 10. Successful bidders must submit the security deposit of 5% of contract value including GST. EMD amount of Rs.2750/- of the successful bidders shall be converted to security Deposit and balance amount shall be deducted by ITI from the vendor's first three payments.
- 11. EMD/Security Deposit submitted by the bidders may be forfeited:
  - a) If Successful bidders Backs Out after bidders may be forfeited
  - b) If the successful bidders withdraw from contract before the expiry of contract period the security Deposit will be forfeited
  - c) If the successful bidders violates any of the terms and conditions of the tender the security Deposit will be forfeited
  - d) If the successful bidders found to have indulged in fraudulent practices in the tender submission process the EMD will be forfeited.
- 12. The EMD/Security Deposit will not carry any interest.
- 13. EMD EXEMPTION: The bidder seeking EMD exemption must submit the valid supporting document for the relevant category with the bid. Under the MSE category, only Manufacturers of Goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.
- 14. Period of supply One year from 1<sup>st</sup> June 2025 to 31<sup>st</sup> May 2026.
- 15. The Material has to be delivered at our canteen premises inside the company without any extra cost.
- 16. Rate quoted will be same till the completion of contract.

- 17. Item as per specifications in Annexure-1 should be supplied.
- 18. Final acceptance of the materials will be subject to inspection at ITI canteen. Materials fully/partially rejected have to be replaced by acceptable quality materials and delivered at ITI Canteen Premises.
- 19. Requirement for the supply will be communicated on previous day. ITI can increase/decrease the quantity as per the need.
- 20. The items are to be supplied Every Monday and Thursday between 9.00 to 09.30 AM. However, based on requirement from ITI ,Materials have to be supplied as and when requisition is raised. The payment will be made on monthly basis, after 30 days from the date of submission of invoice.
- 21. Approximate weekly requirement is as per Annexure-I
- 22. In case of Poor supply in the quality and quantity of item, then ITI reserves the right to terminate the contract by giving one week notice.

#### 23. INSTRUCTIONS FOR PREPARING BID DOCUMENTS

The Bid will be processed on a two Bid system. There shall be Technical Bid and Price Bid

The documents shall be submitted in three sealed covers super scribing Enquiry and due date and separately marked as following:

- a) Technical Bid
- b) Price Bid
- 23.1.The cover marked Technical bid shall have the following documents:
  - 23.1..1 Proof of EMD payment or MSE Certification, if the exemption is claimed.

#### 23.1..2 Scanned copy of the following documents:-

- GST Registration certificate
- PAN Registration certificate
- · License for trading white bread
- Proof for authorised/wholesale distributer of the brand.
- Proof of address
- 23.1..3 Duly signed and sealed copy of **Annexure-I**
- 23.1..4 Each page of the bid document shall be signed by the bidder. The Signed document for acceptance of all the terms and conditions of the bid.
- 23.1..5 All the above said documents shall be submitted in a sealed cover and must be marked on the cover as "Technical BID"

**Important**: All the documents submitted against tender should be properly indexed indicating attached certificate Name and Page Number in the first page. Files without index will not be considered for Technical evaluation.

#### 23.2. Price Bid:

The price bid shall be in the format given in **Annexure-II**. The format should be filled in all respects. Price quoted should be inclusive of all taxes. The price bid shall be put in a sealed cover and must be marked on the cover as "PRICE BID"

- 23.3. Two sealed covers (Technical bid and Price bid) shall be submitted in an outer cover and sealed. The outer cover shall bear the details of Tender ref ITI/PKD/HR/2025/1214 and due date as 20/05/2025
- 23.4. The bidder is expected to examine all requirements, terms and conditions of the tender. Failure to furnish required information in every aspect or non-submission of necessary proof and relevant document or non-submission of EMD
