In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.

9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

INSTRUCTION TO BIDDERS

Tenders will be accepted under the two bid system:-

(a)- **The Technical Bid:-**

1:-Satisfactory completion certificate for similar nature of works (Similar works like Housekeeping/Horticulture work of factory/Township area) issued by competent authority not below the rank of Executive Engineer of above-mentioned departments in the last five years.

- a. Execution of single order of 50% of estimated value.
- b. Execution of two orders of 30% of estimated value.
- c. Execution of three orders of 25% of estimated value.

(2)- **Estimated cost:-Rs :-12,62,000/- (Including GST@18%).**

EARNEST MONEY Rs:-22000/-(Twenty-two thousand only) through DD/FDR in favor of ITI LIMITED Rae Bareli. It will be returned to unsuccessful bidder after the finalization of the tender.EMD will be forfeited who backs out or is found to be providing misleading information during tendering process. Registered with MSME is exempted in case of MSME Bidders for which MSME Certificate must be submitted.

(3):- Successful bidder has to security deposit @5% of work order value.

- (12)- Tenderers are requested to bring original documents or certificates whenever demanded.
- (13)- All partners must sign the tender documents submitted on behalf of a firm, or the documents must be signed by a partner/authorized person who has the authority to enter into the proposed contract on behalf of the firm/company. Otherwise, the tender is liable to be rejected.

The Price Bid :-

- (a):-It shall contain the rates in the Bill of Quantity, duly filled in and signed by the bidders as a token of acceptance.
- (b)-The Price Bid of only those contractors will be opened whose Technical Bids are found suitable.
- (c) Conditional tenders will not be accepted.
- (d) Offers must be submitted online only.
- (e) The bidder should clearly mention all government levies; otherwise, it will be presumed that the quoted rates are inclusive of all taxes.

GENERAL CONDITIONS

1. Performance Guarantee & Security Deposit:-

(a) The successful bidder shall deposit 5% performance guarantee in the form of FDR/DD in favor of ITI Limited, Rae Bareli, against the accepted tender value, before commencement of work.

(b) The security deposit shall remain at the absolute disposal of the Company as security for satisfactory execution and completion of the works. The full amount will be refunded after the expiry of the defund liability period of 02 months from the date of successful completion of work.

(c) The Company shall be at liberty to deduct appropriate amounts from the security deposit against compensation or dues payable by the contractor under the contract. Such deductions shall be made good by further deductions from subsequent interim bills until the security deposit is restored to the required amount.

(d) If the contractor fails to commence execution of the work after the award, the Company shall be at liberty to forfeit the EMD/Security deposit absolutely.

(e) EMD is exempted in case of MSME Bidders and Start-ups Bidders. Start-ups Companies may be exempted for experience.

(2):-The Bidder shall be liable for ensuring compliance with the provisions of all applicable laws including but not limited to labour law and specially workmen compensation Act, EPF Laws, Income tax laws and minimum wages laws, Contract labour(Regulations Abolition Act),and any other relevant acts as may become applicable during the tenure of contract and while filling the BOQ. SPECIFICATION

Name of Work: Horticulture maintenance works in Township.

01- The sole responsibility to upkeep the gardens, hedges, lawns, kitchen gardens, potted plants, horticulture nursery shall be with the contractor which shall include necessary steps such as;

A- ITI House and Public Buildings (Guest House, Antwerp House and Hospital Area)

(a)- For Lawns:

- 01- The contractor has to water the lawns as many times as required so that lawns are always lush green.
- 02- Mowing/grass cutting has to do regularly or as per requirement and keep the lawns free from weeds.
- 03- Clipping of hedges on regular basis in three dimensions i.e. both sides & upper at required height and thickness.
- 04- Spreading of good earth, manure, fertilizers, sprinkling of water etc. have to be done as per requirement.

(b)- Kitchen garden and Horticulture Nursery Area:

- 01- Preparation of seasonal beds, manuring, plantation of seedlings, sowing of seeds, watering, hoeing works have to be carried out season wise as per directions of Engineer – in – Charge.
- 02- The contractor have to buy vegetable seeds, plants, seasonal flowers etc. of Rs. 1000/- per month and submit the bill along with the RA bills or as directed by Er-in-charge.
- 03- Manuring, spreading of fertilizers, plant medicines, de – weeding of the beds and maintenance of kitchen gardens, plants as per need basis.

(c)- Existing Potted Plants:

- 01- Watering the ever green potted plants carefully as many times as required.
- 02- Manuring, de – weeding potted & repotted of the plants and proper maintenance & development of the potted ever green plants.
- 03- Preparation of pots by filling mixture of manure & good earth in required proportion. Plantation of seedlings, de-weeding, hoeing, watering, sticking, threading etc., maintenance of potted seasonal plants as per directions of Engineer – in – Charge.
- 04- Spraying/spreading of manure/fertilizers, plant medicines on need basis.
- 05- Preparation of supporting sticks for potted plants is contractor's responsibility.

(d)- New Potted Plants:

- 01- Preparation of seed beds, sowing of seed, watering, weeding of seedlings etc.
- 02- Preparation of ever green hedge plants/timber plants by way of cutting & through sowing its seed as per requirement.
- 03- Supply of prepared seedling, plants, hedge plants etc. for plantation in different places being the areas maintained by the contractor including seasonal beds of Nursery also.

B- D-Type Hedges and Lawns:-

- 01- Cutting of all the lawns will be done by the contractor once in a two month.

- 02- Clipping of hedges once in two month in three dimensions i.e. both sides & upper at required height and thickness.
- 03- Watering & manuring etc. as per need basis.
- C- Transportation of potted plants (ever green/seasonal) for decoration at various places and its arrangement in decorative fashion on the various occasions as well as normal day to day maintenance works is the responsibility of the contractor.
- D- Deployment of labors for watering & maintenance and arrangement of pots etc. during holidays, special occasions and as and when required. The numbers of gardeners/labors shall be arranged by contractor as per direction of Er.-in-Charge.
- E- It shall be the responsibility of the contractor to see that no damage occurs to the horticulture plants and company's properties, in case any damage occur, the contractor shall be liable for payment of appropriate compensation as fixed by the Company.
- F- All the horticultural operations shall be carried out by the contractor under strict supervision and direction of the Engineer – in – Charge.
- G- Supervision of the work carried out by the workman providing proper direction and guidance regarding manuring, applying pesticides and treatment of plants disease and taking such other actions as and when required for the well being and healthy development of the plants, gardens in the said premises being maintained by the contractors.
- H- The scope of work includes trimming of tree branches etc. that are done on need basis within the ITI township premises in all the sectors i.e. Sector-I, II & III by deploying appropriate labours & tools machinery and disposal should be carried out at ear-marked location as per instruction of Er-in-charge.
