1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. This contract for periodical servicing of weighing & counting machines will be for a period of one year from date of placing of PO.
- 2. Servicing to be done twice in the above said period of one year.
- 3. The first schedule of servicing to be done within 1 week from placing of PO and the second schedule of servicing to be done after 6 months of 1st servicing of machines and your quote d rates are to be provided for these two schedules of servicing.
- 4. The service premium shall be payable by us on presentation of your bill after each servicin g schedule.
- 5. You will arrange with weights and measures department Government of Karnataka for verif ication and stamping of weighing scales and weights under this contract within 1 week from placing of PO but the fees and expenses of the metrology official shall be met by us fully on presentation of the bill.
- 6. You shall be responsible for the implementation of the provisions of the factories act and in default of compliance with any of the provisions of the said act you shall identify the company for any damages, penalties, fines, claims or any other cause of action against the company on account of any action by the inspector of factories or by other authority or person.
- 7. Disputes if any will be within the Jurisdiction of Bangalore, Karnataka State, India.
- 8. **Terms of price**: FOR, ITI Ltd Bangalore.
- 9. **Payment Terms**: Payment will be made half yearly on completion of Calibration, Verificati on & Stamping of weighing Machines within 15 days from the date of Invoice. Payment will be made only after the acceptance and certification by User department that the Calibration, Verification & Stamping of weighing Machines is done satisfactorily.
- 10. Bid validity: 180 days
- 11. **Duties & Taxes:** if any may be indicated.
- 12. **PO Extension:** After mutual consent of both the parties, the contract period may be extended one more year.

SERVICING DETAILS OF WEIGHING & COUNTING MACHINES

- 1. This contract includes all repairs charges necessitated by wear & tear during the period of servicing. Free replacement of fitting will be attended to by the servicing party when fou nd necessary such as all knife edges, steel or agate bearings, shackles, links, steel legs and stays, inspection rods, ribbons, screws, bolts, nuts, look through glasses etc. The dashpot oil should be replaced with a suitable grade oil.
- 2. This contract however does not provide for the replacement or repair charges of broken structural parts such as box, plate, levers, pillar assembly, mounting wheels etc.
- 3. The machines should be painted wherever necessary.
- 4. Properly trained staff to be sent to examine service adjust and test the machines at the time of servicing.
- 5. The necessary test weights and labour will be provided by you during the period of servi cing.
- 6. If the machines under this contract go out of order in the intermediate two servicing sch edules or within the above said period of one year, skilled machines will have to be sent to our works on intimation by telephone or otherwise to set right the machines.

Note: Clause wise Compliance to the Annexure - A,B and C from the Bidders on L etter Head is mandatory and to submitted along with the bid documents.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

- Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
