The consortium partners has to be exclusive for the clusters, and are ready to work with ITI.

Note:

- a) Any bidder may bid in one or more clusters or even for all the clusters.
- b) Bidder has to submit bid security for each cluster which can also be submitted as a single Bid security for multiple clusters. Maximum bid security for participation in more than 3 clusters is Rs 6 cr.
- c) In case a bidder bids for more than one cluster, then the turnover of highest turnover cluster plus 50% of required turnover of other clusters will be sufficient to bid.
- d) In case a bidder bids for more than one cluster, then cumulative experience of all the clusters will be required to be eligible for all clusters bided for. Bidder, having experience of 2000 sites/ towers or more will be eligible to bid for all clusters. In case of O&M experience, minimum period for consideration will be 12 months.
- e) The experience of the Bidder/consortium partners may include the experience of its/ their parent company; such Bidders shall also submit a 'Front Bidder Agreement' in the proforma available at Section-7 Part (K). The bidder shall also submit a 'Resolution' duly passed by the board of Directors of the Parent company stating that the Parent company shall support and take responsibility with respect to all the contractual obligation by its subsidiary company (the Bidder) for this project.
 - Documents required: Work Completion certificate establishing the above conditions, issued by entity who has successfully completed the work is to be enclosed as proof along with contact details of the client i.e. name of contact persons, postal address, official email, telephone number shall be submitted.
- f) All the technical bids, received in the tender, shall be opened and evaluated for all the clusters. The technical bids for a bidder shall be evaluated in the order of cluster rank, starting from Cluster -1. While evaluating the technical bids, the cluster wise technical experience and financial capacity of a bidder shall be taken as consumed, before evaluating it bids for next cluster. Thus, the bid in the next cluster shall be evaluated only if sufficient technical experience and financial capacity is left available and shall be considered responsive, if the bid meets all the eligibility requirements.
