The terms and conditions of the quotation are as under;

- 01- The agencies are requested to quote the per quintal rates of fallen Eucalyptus logs in the below mentioned schedule of quantity. The approximate weight of these Eucalyptus logs will be 300 quintal which may be variable as per actual weighing. Interested parties may visit the site.
- 02- Bidder has to submit the tender bid with tender Ref. & due date on sealed envelope at the address central dispatch office , ITI Limited Sultanpur Road, Rae Bareli UP - 229010 .
- 03- Agency have to borne all the charges i.e. transportation, labor/machine charges, T& P and weighing charges.
- 04- Weighing and lifting of fallen Eucalyptus logs as offered from committee should be carried out in front of committee members.
- 05- EMD of Rs 5000/- is to be deposited in shape of DD / FDR favoring ITI Limited Rae Bareli , payable at Rae Bareli, along with NIT. If the party does not deposit EMD of amount Rs5000/-the tender bid will not be considered for evaluate.
- 06- Successful H-1 bidder have to deposit complete payment including all taxes in favor of ITI Limited, Rae Bareli A/C No: 00520200000319 Bank of Baroda, Main Branch, Rae Bareli IFSC code: BARB0RAEBAR through RTGS/NEFT or cash deposit.
- 07- The agency should have to lift mixed type Eucalyptus logs including dead roots upto minimum 20% by total weight of complete lot.
- 08- The lifting of Eucalyptus logs will be done as on where basis and transportation including all the permits shall be borne by agency itself.

- 09- GST @ 5% or whichever applicable shall be borne by agency itself over the total amount.
- 10- The decision of committee shall be final and binding on the agency and ITI reserves the right to accept or reject the quotation.
