Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. Also this is not going to be used as a criteria in determining reasonableness of guoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

PRE-QUALIFICATION CRITERIA AND SUPPORTING DOCUMENTS

1. The Contractors having experience of executing above types of supply of manpower works under a single contract may apply with detailed certificates / credentials to the Addl. General M anager (CS), ITI Bangalore Plant, Bangalore.

2. Should be continuously making profit during last three years.

3. Annual average turnover of the Firm / Company / Agency should be minimum Rs.23 Lakhs d uring the last three financial years.

4. Experience of having completed similar works during the last 3 years ending previous day of last date of submission of bids

 $\cdot\,$ Should have carried out minimum 1 similar work during last 03 years with work order value n ot less than 80 % of the estimation.

OR

 \cdot Should have carried out minimum 2 similar works during last 03 years with work order value (individually) not less than 50 % of the estimation.

OR

 $\cdot\,$ Should have carried out minimum 3 similar works during last 03 years with work order value not less than 40 % of the estimation.

5. The tenderer should have applicable Tax registrations (GST, PAN).

6. The tenderer should have valid GST No.

7. Income Tax Returns of the last 03 financial years in the name of the firm.

8. Tenderers should have a current / savings bank account with a scheduled commercial bank.

9. The contractor should have a local office at Bangalore city. The documentary evid ence of the same along with GST registration & Labour License has to be submitted a long with the bid. No undertaking on future establishment of office will be entertaine d. Bids without required documents will summarily be rejected.

10. Tender will be accepted by Two-Bid system through GeM Portal only.

11. ITI Limited reserves the right to verify any or all the documents furnished by the tenderers with any a uthorities. ITI Limited also reserves the right to cancel any or all the applications without assigning any rea son thereof.

12. Intending applicants are required to furnish details about their firm/organization, experience, compete nce etc. as per the proforma. Failing which shall lead to cancellation of application of tenderer.

13. While deciding upon the selection of tenderers, emphasis will be given on the ability and competence to do good quality work in accordance with the specifications and within the time schedule.

14. The Tender form should be signed by a person on behalf of the Firm/Organization, who is duly authori zed to do so.

15. If the space in the Tender form is insufficient for furnishing full details, such information m ay be supplemented on a separate sheet of paper duly signed.

16. Applications containing false or inadequate information are liable for rejection and ITI Limit ed reserves the right to blacklist those agencies. Any agency blacklisted /debarred by ITI Limite d will be ineligible to participate in the tendering process.

17. The Owner/ CEO/Authorized Representative should be available in person for weekly review me etings or as and when called by ITI Limited. In case of non-availability of Owner/CEO/ Authorize d Representative for the said meetings on two or more occasions, ITI Limited reserves the right to terminate the contract.

18. Solvency Certificate and valid income tax clearance certificate are to be furnished. The mini mum Solvency value of Rs. 3040360/- to be furnished. Please note that the Solvency certificate issued by the Banks on or after April 2024 only will be considered.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्ते, conditons stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
