- 2. AMC has to be done for the list of CAPEX Wet Processing Machines for AMC in the PCB Plant given at Annex

ure-I as per scope of work as mentioned at Annexure II of this RFP.

- 3. After completing AMC, Service certificates have to be provided.
- 4. Disputes if any will be within the Jurisdiction of Bangalore, Karnataka State, India .
- 5. Terms of price: DAP, ITI Ltd Bangalore.
- 6. **Payment Terms:** The payment will be made once in three months within 3 months on receipt of Tax Invoic e upon satisfactory completion of Preventive Maintenance, attending to break down calls. The bill has to be certified by the user department.
- 7. As no PBG is applied for this tender, M/s ITI will withhold the amount equal to BG i.e 3% of total contract value on prorate basis & pay the retained amount at the end of AMC period. This 3% a mount will be deducted from the 1st quarter of AMC Bill.

In case of any change, the supplier should inform us in advance and obtain approval to the revised delivery schedule should the supplier fail to deliver the material in full/ part thereof, we shall be entitled at our option either to recover from the supplier as agreed the liquidated damages and not as penalty, a sum equivalent to half percent of the contract price of the item per week of such delay or part thereof subject to maximum of 5% of the contract price of the item delayed or to terminate the contract in respect of balance quantity so delayed and purchase material elsewhere at the risk of supplier.
