 - (g) The bids must also be accompanied with Tender Document Fee of Rs.500.00 (Five hundred only)
- 2- All MSMEs notified as per GFR 2017 clause no. 1.10.4 shall be exempted from payment of Tender Document Fee and Bid Security/ Earnest Money Deposit. The same shall be encased in case vendor fails to execute the order to our satisfaction in all respects. This PBG will be returned after satisfactory completion of warranty period ITI, Limited will not be responsible for non-receipt / late receipt or loss of tender documents in postal transit.
