12- Compensation for Delay:

- a) If person is found absent from the site. Instantly, Contractor shall be intimated to make an alternate arrangement against the deployed manpower. The deduction will be made for absence period on prorate basis of wage given by payment of the contractor.
- b) Token penalty of Rs.250.00 is levied if sewerage water level exceeded to danger mark.
- c) A compensation of Rs. 500.00 will be imposed in case of failure of machines entail to delay in operation due to negligence of preventive maintenance such as heavy water leakage, gland dori replacement and serious mechanical / electrical maintenance like misalignment of pump-motor sets, starters relay/ fuse malfunctioning / blown.
- d) The complaint towards breakdown / failure of machines received/recorded should have to be attended immediately. In any case it should not exceed 24 hours failing which Rs. 700.00 (Rs. Seven hundred) per day will be deducted due to non-operation of machines. A part of above if all machineries installed in the sump well immersed due to raised sewerage water will be treated as negligence of contractor and all motors/ machineries rewinding/ repairing is sole responsibility of contractors.
- e) Apart from above, if all machineries installed in the sump well immersed due to raise in level of sewerage water will be treated as negligence of contractor and in this case contractor shall be solely responsible for rewinding/ repairing of all motors/ machines.
- 13- The consumable materials like gland dori, grease, fuse wire etc. will be part of contractor
- 14- The machining of equipment, HRC fuses, relays, switches and starter shall be provided by ITI Limited.
- 15- The operation of sewerage water disposal pumps is required round o' clock. Sufficient persons have to be posted for the work as indicated in bill of quantity on all the days in a month. Minimum one person should be present on the site for operation and skilled manpower for carrying out the preventive maintenance / break down rectification work
