### **GENERAL CONDITION**

1-The work will be carried out as per general and special conditions of contract.

2- (a) Earnest money deposit of the successful tenderer shall be converted into security deposit. Total security deposit to be recovered shall be 10% (Ten percent) after adjustment of 2% initial earnest money as security deposit. Recovery of 5% security deposit will be made from first R.A bill on total accepted contract value after adjusting EMD and remaining 5% will be made from each bill.

(a) The security deposit shall remain at the entire disposal of the company as a security for the satisfactory execution and completion of the works. The 50% of the security deposit along with EMD will be refunded after completion of work and payment of final bill. Balance 50% shall be refunded after payment of final bill or expiry of defect liability period (three months) whichever is later.

(c) The company shall be at liberty to deduct an appropriate amount from the security deposit against such compensation and dues as may be payable by the contractor under contract and the appropriation will be made good by further deduction from the contractor's subsequent interim bills until the security deposit is restored to its full limit mentioned above.

4- The contractor shall at all times indemnify the company against all claims, damages or compensation under provision of payment of wages Act 1936, MinimumWages Act 1948. 7-The contractor will take all adequate steps to ensure the safety of the workers employed

by him.

8-The contractor shall provide all necessary protective equipments and tools to the workers for safe execution of work.

9-In case any worker employed by the contractor prefers claim under workmen compensation Act. ITI shall be at liberty to recover such amount or any payment thereof from the dues of the contractor.

10- ITI Ltd., reserves the right to remove any labour/staff of the contractor without assigning any reason.

11-The contract can be withdrawn/terminated at any time without notice.

12-The tenderer must sign all the papers attached hereto and submit along with tender.

- 13- In case of any dispute decision of the UNIT HEAD- (M) ITI, Ltd., Mankapur shall be final and binding on both the parties. Courts of Gonda only shall have the jurisdiction in case the matter goes to courts.
- 14- Payment will be made monthly on submission of RA bills. Final bill will be paid within three months from the date of completion of the work on submission by the contractor.
- 15- The contractor shall be held responsible for any misdeed of his labour/representative and shall have to compensate ITI Ltd., Mankapur for any loss.

- 1-The time allowed for completion of work will be 12 months which may be extended for further 12 months on mutual consent.
- 2-The quantities of jobs taken in BOQ are tentative and can vary on either side as per requirement by user department on as and when required basis.Contractor will have to arrange extra manpower for unloading of additional trucks during urgency.
- 3-The unloading of raw materials packed in bags containing 25 kg each and 800 bags (approx) in number from the trucks will have to be carried out on an average 02 trucks daily round the clock..These bags will be unloaded and placed in the store as per direction of shop incharge with in 04 hours of arrival of truck.
- 4-The contractor will have to arrange extra and sufficient man power for unloading additional materials brought during urgency of work.
