# (I) TERMS AND CONDITIONS

1- E-tendering Instructions to Bidders: Submission of Bids shall be only through e-tendering process on <a href="https://itilimited.euniwizarde.com">https://itilimited.euniwizarde.com</a> which is mandatory for this Tender.

2- Stages of Tenders- Tender Type: Two bids i.e.; Technical and Financial Bids shall be submitted by the bidder at the same time on the above mentioned tendering portal.

Note: It is advised that all the documents to be submitted are kept scanned or converted to PDF format in a separate folder on your computer before online submission. Price Bid (Excel Format) may be downloaded and rates may be filled appropriately. For any portal related issues contact: 7903267845 and 9355030630.

3-Validity of Bid / offer- Bid shall remain valid for 150 days

4- As per Rule 170 of General Financial Rules (GFRs) 2017, Micro and Small Enterprises (MSEs) and the firms registered with concerned Ministries/ Departments are exempted from submission of Bid Security/EMD. Instead bidders have to submit duly signed "Bid Security Declaration" accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents.

5- Please quote the basic rate exclusive of GST and other Taxes (i.e. mention basic rate, GST, freight, taxes separately). Also confirm that documents will be issued for claiming CENVAT.

6-Any product / item / Machine or equipment found faulty during our manufacturing process / system Testing / installation and commissioning / operation of our equipment in field due to deviation from our specifications shall be replaced by vendor free of cost immediately.

7- Last date of Clarification: - The last date of seeking any clarification regarding bid is 05/12/2022.


# Salient Terms and conditions of the tender:-

# 7. Tender Processing, Opening & Evaluation:

- b. Price Bids of only those bidders found technically fulfilling the eligibility conditions and found technically acceptable shall be opened on line on a date to be intimated later.
- c. Complete sets of NIT documents( List given at (e) below) in Original form duly signed using signin process and digital signature by the bidder on each page of the tender documents as a token of having acceptance its contents. Power of Attorney has to be provided in case, the tender documents are signed by an authorized representative.
- 8. SCOPE OF WORK: As per enclosed Annexure –I,
- 9. This is only an enquiry to quote and not an order. This tender enquiry is not transferable
- 10. Tender submission last date- 09/12/2022
- 11. Tender opening date:-10/12/2022
- 12. Bidder shall clearly mention all govt duties/taxes/GST. If any discrepancy/missing found, Quoted price shall be treated as all inclusive.
- 13. Compliance of Minimum wage, PF, ESI, ELDI and other benefits to the employees as per government of UP at your end.
- 14. After opening of bid, no clarification shall be considered regarding commercial offer. It will be treated as post tender negotiation. If any discrepancy/missing found in any bid/s, Such bid/s shall not be entertained.
- 15. If the bidder(s), during tender process or thereafter has committed a transgression in violation, in any form such as to put his reliability or credibility in question the ITI LIMITED is entitled to disqualify bidder from the tender process. In such cases the severity will be determined by ITI Limited, Raebareli taking in to consideration full facts and circumstances and Bidder(s) may be blacklisted for future tender/contract award process after forfeited EMD.
- 16. If any wrong statements/misleading/fraud practices found at any stage of tender or thereafter at any stage, Bidder's EMD may be forfeited. However further penalty/legal action or both may be initiated.
- 17. **CONTRACT PERIOD**: The Contract period will be one-year from the date of award of work order & it may be extended, if required, on mutual consent for a period of two months maximum.
- 18. **PAYMENT TERMS**: 100% payment will be made after successful completion of work. However, running payments may also be considered on Pro- rata basis, if desired by the contractor. Mode of payment will be electronic fund transfer.
- 19. **MSME** bidders are required to submit valid certificate issued by NSIC/MSME along with Bid Security declaration (As per annexure II) to claim EMD/Bid Security exemption.
- 20. **PF Registration** certificate is to be submitted and compliance of the same may be ensured by the bidder. The contractor shall be liable to pay his contribution and employees' contribution to ESI & EPF scheme



in respect of all workers employed by him for the execution of the contract. The monthly payment of ESI, PF and administrative charges applicable are to be made regularly and the proof of such payment may be asked if required. (Copy of Registration certificates as a proof shall be provided).

- 21. The contractor shall ensure timely payment to the workers engaged by him as per relevant provisions of Payment of Wages Act 1936. The payment on each running bill of the contractor will be released only after satisfying the disbursement of payment to the contract labour engaged and adhering to all statutory provisions in force.
- 22. The workers engaged by the contractor shall strictly observe factory discipline.
- 23. **PENALTY:** Penalty will be double of the value of non-delivery period and will be deducted from running bills. In case of poor & unsatisfactory services, penalty at same rate may be imposed and continuous unsatisfactory services may result in cancellation of the contract at any stage.
- 24. TAXES DEDUCTIONS: It will be applicable as per govt. rules.
- 25. As per govt. norms, while making payment 2.5 Lakhs & above, 2% GST TDS will be deducted
- 26. Bidder shall submit undertaking regarding non-blacklisting/debarment to participate in any Central/State Govt./PSUs/Autonomous bodies' tenders on their letter head as per Annexure-III.
- 27. Bidder shall strictly use necessary personal protective equipments like safety shoes, hand gloves, etc so as to work safely. ITI ltd will not bear any responsibility for any accident during execution of work.
- 28. The Successful Bidder shall submit Work Order acceptance within one week of Work Order issuance by the Tenderer. Agreement of contract should be submitted on Stamp Paper of ₹100.00 at the time of award the work order.
- 29. The work shall commence immediately on issue of Work Order as per the Work Order conditions.
- 30. All tools and tackles will be arranged by the Contractor for execution of the work.
- 31. In case of any casualty or accident during execution of work happen to contractor's technicians/ workmen in ITI Limited premises, Raebareli. ITI limited will not take any responsibility and contractor will be solely responsible for the same.
- 32. The Contractor will indemnify ITI ltd from losses /damages cause to ITI Ltd by his persons or by negligence of them, and the same may be recovered from their running bill if not indemnified within due course of time.
- 33. Electricity & water will be provided free of cost by ITI Ltd Rae Bareli for execution of work.
- 34. Other standard terms and conditions of ITI Ltd shall be applicable & to be complied.
- 35. Prospective bidders are advised to visit the site and assess the scope of work before submitting the bid.
- 36. Dispute, if any, will be under jurisdiction of Rae Bareli, UP.




