If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 1. The Contractors having experience of executing above types of **Service Works Contract in Horticulture/ arboriculture** under a single contract may apply with detailed certificates / credentials to the Deputy General Manager (CS), ITI Bangalore Plant, Bangalore
2. Should be continuously making profit during last three years.
3. Annual average turnover of the Firm / company / Agency should be minimum Rs.22.08 Lakhs during the last three financial years.
